This workshop is free of charge to you. You will be provided with a workbook that you will use throughout the workshop. **You are required to be registered for the December 2018 ACT, and agree to be on time and stay for the entire workshop.**

- Provide a certified Mastery Prep Instructor & ACT Boot camp manual.
(*No materials may be sold or used in a paid workshop without permission.*)

To be considered, students must complete each of the following requirements:

1. Submit the most recent **OFFICIAL** ACT score report with your application.
2. Be registered for the official December ACT (*deadline to apply without a late fee is Nov. 2*) and submit a copy of their admission ticket.
3. Attend the entire workshop, you are not allowed to leave early.
4. Sign and return the “Release of Records” form with your application.
5. Submit a copy of your CDIB card with your application.
